Expenses

We have allocated a 10,000 USDC budget for web services used in development and operations.

Carryover

We had significant carryover from the previous cycle because it spanned 4 months and included a budget item that later became obsolete (see “Previous cycle” below). We will continue carrying this amount over to the following cycles until it runs out.

10% Headroom

This cycle’s budget is planned exactly, not expecting any additional expenses. We are requesting a 10% headroom on top of the total budget to provide some flexibility. Any unspent amount will be carried over to the next cycle.

Deliverables

The team’s work is kept in [public repositories](#) and can be reviewed in real time. The team has been posting reports since as early as [December 2020–January 2021](#) and will continue to do so.
